In exercise of power conferred by section 22 (b) and 34 of the Bangladesh Energy Regulatory Commission Act, 2003 'Retail Electricity Tariff' of Bangladesh Power Development Board, PBSs under Bangladesh Rural Electrification Board, Dhaka Power Distribution Company Limited, Dhaka Electric Supply Company Limited, West Zone Power Distribution Company Limited and Northern Electricity Supply Company Limited has been determined as follows with effect from bill month December 2017:

Retail Electricity Tariff

Frequency : 50 Hz
Sanction Load : Single Phase 0-7.5 kW & 3 Phase 0-50 kW

¹The existing energy rate/charge of Life-Line (0-50 Unit) consumers will remain unchanged for those *Palli Biddut Samitis* (PBSs) under Bangladesh Rural Electrification Board (BREB) whose energy rate/charge is above 3.50 Tk./kWh. Consumers under LT-A category who consume electricity more than 50 kWh will not get Life-Line tariff benefits.

² For determining Demand Charge, the Electricity Demand (kW) have to be considered as below:

- A) For all LT, MT-1, MT-2 and MT-6 consumers, Sanction Load (kW) will be applicable.
- B) For MT-3, MT-4, MT-5 and all HT & EHT Consumers, recorded Maximum Demand (kW) or 70% of Sanction Load which one is the highest will be applicable.

³ Energy Rate/Charge for the consumer class of MT-5 under Bangladesh Power Development Board, Dhaka Power Distribution Company Limited, Dhaka Electric Supply Company Limited, West Zone Power Distribution Company Limited and Northern Electricity Supply Company Limited whose electricity usage is mainly (about 80%) residential type such as-Cantonments/Universities with dormatories will be as follows:

20% of electricity usage will be charged at MT-5 energy rate/charge (8.05 Tk./KWh), 72% of electricity usage will be charged at average energy rate/charge of first and second slab of LT-A (4.91 Tk./kWh) and 8% of electricity usage will be charged at energy rate/charge of sixth slab of LT-A (10.70 Tk./kWh). *Palli Biddut Samitis* (PBSs) under Bangladesh Rural Electrification Board will follow energy rate/charge of MT-5 as per previous sequential rule for whole electricity usage by the consumers under this category.
